Also, spraying of Cumbungi weed in Macquarie River; this issue has been raised before and it is not a matter for NMC. Although river is in the NMC area, requests need to be progressed through State Growth who are the responsible agency. Not likely to use spray in the river area. Old Cemetery has become very hard to park on side of the road as it has been washed out. Chair to put in works request.

K Jolly - When is the village green going to be finished? Response was hopefully May next year, depending on weather issues. Hoping to have a special function there in June 2021. Mayor advised there will be an opening ceremony as well – although the Village Green may be able to be used before this ceremony.

R Hebbard - Pot holes and asphalt edges in all streets need attention. Are NMC aware that the Town Hall gutters are full of leaves. Rabbits overrunning Badajos Street (all through town). Was bait put out this year or not, due to Covid? Need to ensure it is progressed next year.

Jacobs Consulting Presentation

A project update and question and answer session was conducted by Jacobs Consulting personnel Catherine Searle (Lead Principal Consultant), Troy Prince (Project Manager), and Julian Koning (Design Lead For The Ross Section) regarding the Midland Highway safety upgrade.

Jacobs are Consultants to State Growth, and are conducting community consultation on their behalf for the Midland Highway final stage safety upgrade. The final stage project has been ongoing since middle of last year, including rounds with property owners along the Midland Highway. The design is yet to be finalised, todays presentation is a brief overview of what is currently being proposed.

Background – The Midland Highway upgrade is a 10 year action plan and is currently into its 5th year with an estimated completion date of 2024. The final stage includes Jericho to South of York Plains, Mona Vale Rd to Campbell Town and Campbell Town to Epping Forest, approximately 51 kms in total.

Currently the highway is 1-2 star, widening with centre lane dividing wire will improve to a 3 star safety rating. 5 star rating is the highest that can be achieved. Safety the main factor of the upgrade. Public road access from the sides of the highway will be kept. Left & right turn dedicated lanes to be kept. Heavy industry / farm access will be needed. Safety cuts down overtaking, so will be looking at putting in overtaking lanes and where the turn facilities will be. Roseneath, Auburn, Ashby and Chiswick Road to have access to highway, wire rope otherwise. Turning circles at Little Chiswick, Lewisham and south Campbell town.

Public consultation has led to feedback and to discussion with Government about the feedback. Lots of issues, devil is in the details. Another round of Public Consultation in February/March and will consult on the next iteration of the plan. Need to gain an understanding of how properties blend / interact with highways. Discussion with public re extra overtaking lanes which appears to be the most relevant submission along with the Chiswick Road intersection.

Q&A

- Have school bus operators consulted yes & again, safety of children paramount re stopping on highway. The school bus is a nightmare particularly in winter exiting Chiswick Road to the Highway. Quite dangerous to pull out due to lack of visibly caused by fog. Trees can be dangerous and hinder sight.
- When was the last traffic count on the Midland Highway held not able to be answered. State
 Growth has permanent counters near Mona Vale. Is it possible to provide a traffic count from
 the Mona Vale counters please? Last traffic count along Chiswick Road was approx 900
 vehicles per day.
- Concern expressed about passing lanes. Looking at 2 lanes in each direction in future, but some confusion about this. Can the exact number of passing lanes between Mona Vale and Ross be confirmed please? Entrance to Ross is apparently safe sight distance is this correct? Is it also feasible to retain the existing 4 lane overtaking section on the Campbell Town straight from Little Chiswick Gates to Young's Corner?
- Ashby Road, right & left hand turn lanes needed and a "speed up lane" as it is a 110 km zone.
 Will both these turns be included in the final design?
- The Chiswick Road intersection is of primary concern to a great number of Ross residents.
 Recently a B.Double at the entrance almost had a collision with another vehicle. Have you had discussion with heavy vehicle drivers, no, but in contact with Tasmanian Transport Association

truck industry. This intersection badly needs redesigning with the entrance moved more to the south to provide clearer line of sight and also needs to have a north bound speed up lane incorporated particularly necessary in winter due to fog etc. Are there any plans to redesign the intersection and incorporate a north bound speed up lane? Trees at the intersection have been raised before and the trees will be removed on the north western side to allow for widening on that side to save Tacky Bridge. Can the trees be removed to the south of the intersection to assist with the line of sight? This intersection may need to be a separate project in its own right as it appears to be very important?

- The Conara intersection has the same dangerous situation as the Chiswick Road intersection above. This intersection also needs a speed up lane. Nature of discussion with the Department, can this be part of the scope or does it need to be a separate safety issue? May need to be its own separate project?
- Federal budget tonight, extra money available will it make a difference to finality of project.
 Phased construction leading up to 2024.
- When can more detail be available on the website that the public can see when you zoom into? Next few weeks hopefully and will be in touch with affected landowners and plans updated to show progress to date.
- Do Jacobs have input into speed limits? Jacobs stated the need to maintain minimal disruption to long term driving and don't tend to recommend reduced speed limits. Improve line of sight and road instead is the preferable alternative.
- Distance of passing lanes are too short and make for aggressive driving. Need to be longer and need to look at increasing the distance. Climbing lanes are being looked at as optimal preference, as inclines slow heavy vehicle traffic and allow safer overtaking. The project is constrained by the brief the Department set. The main aim of the safety upgrade brief is the installation of the central wire barrier leading to improved safety.

The Chair thanked Jacobs for attending the RLDC meeting and stated that while a four lane highway from Launceston to Hobart would be the ultimate objective, any improvements made to the highway would be better than what we have now.

SERVICE AGREEMENT

This Agreement is made the day of 2020

BETWEEN:

THE NORTHERN MIDLANDS COUNCIL

of 13 Smith Street, Longford in Tasmania ("the Council")

- and -

NORTHERN MIDLANDS BUSINESS ASSOCIATION INC

of PO Box 118, Perth 7300 ("the Association")

RECITALS

- The Council has adopted a Business Unit structure for its operation which includes entering into Service Agreements with appropriate organisations throughout the Municipality.
- 2. The organisations are to perform a Council wide function which has a Council wide importance.
- 3. The Association and its activities comply with the Council's objectives.
- 4. The parties agree for their relationship to be specified in this Agreement.

OBJECTIVES OF ASSOCIATION

- 5. The objectives of the Association are specified in item 2 of the Schedule.
- The Council acknowledged those objectives as being consistent with the Council's objectives in this area of activity of the Council.
- 7. The Association, although it is a separate entity from the Council, acknowledges that it shares with the Council the Council's general objectives in this area of activity of the Council.
- 8. The Association will advise the Council if, at any time, it proposes to significantly vary its objectives.

PERIOD OF AGREEMENT

9. This Agreement will commence on the date specified in item 3 of the Schedule and continue for the period specified in item 4 of the Schedule, subject to the terms of this Agreement.

AGREEMENT

- 10. Pursuant to the agreement between the parties as specified in this Agreement the Association will perform certain functions and activities ("the services") and the Council will provide assistance and financial resources ("financial assistance") to the Association.
- 11. The Council recognises the Association as the principal organisation in the Council area for the provision of the services.

STRUCTURE OF ASSOCIATION

- 12. The Association acknowledges that it is an Association registered pursuant to the *Incorporation of Associations Act 1964* and that it will at all times comply with the provisions of that Act and its Regulations.
- 13. The Association acknowledges that it has an effective operational Board.
- 14. The Association acknowledges that it is authorised to enter into this Agreement.
- 15. If the Association alters its Statement of Purposes or Rules in any significant manner it will advise the Council of these changes.
- 16. The parties acknowledge that the Association is a separate entity from the Council and that it will be responsible for its own organisation and conduct. It is not a Committee of the Council.

COUNCIL REPRESENTATION ON ASSOCIATION

17. The Council will not formally appoint a Councillor or Staff Member to the Board of the Association.

SERVICES

- 18. The Association shall undertake such projects and provide such services as it assesses as being appropriate for the economic development of the Northern Midlands region and without in any way limiting the foregoing, the services to be provided by the Association will be set out in detail in the Business Plan of the Association. The Business Plan is to show how the Association is working to assist in achieving the goals of Council's Economic Development Framework (held as an Attachment). The Business Plan will include a detailed description (and where appropriate, analysis) of:
 - 18.1 The goals and strategies required to achieve the objectives of the Association.
 - 18.2 The budget of the operation of the Association.
 - 18.3 The annual survey of Northern Midlands businesses to gauge their level of satisfaction with the Association, with the survey to be developed in collaboration with Council.
 - 18.4 The Association's COVID-19 Safety Plan.
 - 18.5 Any other necessary and relevant matters.

- 19. The Business Plan will operate on two time frames:
 - 19.1 An annual Business Plan will be prepared for each 12 months ("the annual Business Plan").
 - 19.2 The Business Plans will be based on the financial years 1 July to 30 June.
 - 19.3 The annual Business Plan would usually be discussed and reviewed by the parties between the 1 and 30 April each year. Given the delays encountered due to the pandemic, this year the Business Plan will be reviewed by the parties between 1 and 31 October. This review will give consideration to:
 - 19.3.1 The assessment of the achievement or otherwise of the agreed outcomes in the current period.
 - 19.3.2 The assessment of the Association's performance in meeting its budget and its financial performance generally.
 - 19.3.3 An assessment of the programs proposed to be undertaken in the following year and the outcomes by which they will be measured.
 - 19.3.4 A review in light of the previous clause of the proposed financial budget for the Association.
 - 19.3.5 The outcome of this review will be documented and acknowledged by the parties.

REPORTING

- 20. The Association will provide Council with Board Meeting Minutes when they are prepared for each meeting
- 21. The Association will provide an Annual Report plus a six monthly update in sufficient detail to enable a proper review of the:
 - 21.1 Achievement by the Association of its strategies and goals
 - 21.2 Attainment of its nominated outcomes.
 - 21.3 Financial performance as against its Business Plans and generally.
- 22. These reports will be prepared in sufficient detail to enable the annual review to proceed in April each year without delay.
- 23. The Association will report to the Council any substantial variations in its annual Business Plan.
- 24. The Council may request the Association to provide to the Council any further information or documents relative to the Association's performance as is reasonable.
- 25. The Council will be provided with the annual audited financial statements of the Association.

FINANCIAL

- 26. The Council will consider in May each year over the period of the Business Plan, financial assistance to the Association.
- 27. The payments referred to in the previous clause are subject to:
 - 27.1 The objectives of the Association remaining substantially the same as specified in item 2 of the Schedule or being altered in a manner approved of by the Council.
 - 27.2 The structure of the Association remaining substantially the same as at the date of this Agreement or being altered in a manner approved of by the Council.
 - 27.3 The Business Plan having been agreed upon by the parties.
 - 27.4 The annual Business Plan for the next year having been agreed upon by the parties.
 - 27.5 A satisfactory review of the outcomes of the Association's activities in the previous or current year.
 - 27.6 The Association using its best endeavours to attract external income and funding from State and Australian Governments and the Business Community.
- 28. The Council may provide additional funding to the Association during each year for its activities as may be agreed upon between the parties.
- 29. The Association will acknowledge Council's support on all correspondence and promotional materials.

AUDIT

30. The financial affairs of the Association will be fully and independently audited annually and a copy of the audited accounts provided to the Council.

PAYMENTS

31. Payments of financial assistance by the Council to the Association will be made as follows:

Base Grant 2020-2021

\$31,779 GST inclusive

Base Grant 2021-2023

\$31,779 + Hobart CPI as of March each year

LIABILITY

- 32. The Association will endeavour to ensure that its staff and subcontractors do not, represent itself or its activities or its staff as belonging to or being conducted on behalf of the Council.
- 33. The Association acknowledges that the Council is not liable or responsible for the activities of the Association or for its debts, liabilities, expenses, losses or deficiencies.

- 34. The Association acknowledges that this Agreement does not constitute a partnership agreement or a guarantee or indemnity of the Association or its activities by the Council.
- 35. The Association will ensure that it takes out appropriate insurance cover for its activities.

PROBITY

- 36. The Association will ensure that its Board members and staff comply with proper standards of probity including not improperly or unfairly obtaining any financial or other advantages from their position or information at their disposal and not misusing such information.
- 37. The Association's Executive Officer and any Board members working on behalf of the Association within the community will complete Council's online Contractor Induction Program.

TERMINATION

- 38. This Agreement may be terminated by the Council in its discretion if:
 - 38.1 A Controller is appointed to any of the property of the Association.
 - 38.2 Any application is made or resolution is passed for the winding up of the Association.
 - 38.3 The Association is insolvent within the meaning of the Corporations Law.
 - 38.4 A meeting of the Association's creditors is called with a view to entering into an arrangement or compromise with creditors.
 - 38.5 The objectives of the Association being changed substantially from those specified in item 2 of the Schedule.
 - 38.6 The structure of the Association being changed substantially without the approval of the Council.
 - 38.7 The Association fails, for the want of a diligent effort, to substantially achieve the outcomes specified in its annual Business Plan.

DISPUTE RESOLUTION

- 39. Any dispute between the parties to the terms of this Agreement or the performance of the parties pursuant to the Agreement will be resolved as follows:
 - 39.1 The parties will use their best endeavours to resolve the dispute by negotiations.
 - 39.2 If the negotiations are not successful either party may serve on the other a notice of dispute setting out the details of the dispute.
 - 37.3 The dispute will be arbitrated in accordance with the provisions of the *Commercial Arbitration Act 1986* and the parties are authorised to utilise legal representations for such arbitration if they so choose.

NOTICES

Agenda item 2.3 NORTHERN MIDLANDS BUSINESS ASSOCIATION PANDEMIC SUPPORT PACKAGE

NMBA Comments:

In April, 2020, NMBA wrote to Council advising that it did not have sufficient funds to deliver much-needed business support relating to Covid 19, on top of its existing activities.

NMBA followed up with a proposal indicating the types of activities it could foresee at the time to assist businesses during the pandemic.

In response, Council approved and developed a consultancy agreement with NMBA to provide additional support of \$2330 per month for an initial 3 months, with the potential option to extend by an additional 3 months.

NMBA's comment is that it has delivered much more in terms of Covid 19 business recovery activities than indicated in its initial request for support, with clear and measurable benefits for local businesses, and so there should be no question of NMBA underperforming or any reasonable justification of having the existing support funding discontinued.

This letter is to request consideration of the second of two amounts of NMBA Covid-related funding outlined in the approved proposal to Council on 1 April 2020 please.

The first of these blocks of funding provided by Council allowed NMBA to conduct a program of Covid-related business support and communications to Northern Midlands businesses, which would not have been possible otherwise. The proposal involved a \$7000 payment approved by the NMC Executive, with an additional \$7000 which would require approval at a Council meeting.

NMBA has provided several reports to Council on its use of these funds, which are summarised in the attached excerpt from the new NMBA Annual Report.

NMBA special Covid-related funds received from Council and also from the Tasmanian Government have been fully expended, and NMBA has needed to wind down its pandemic-related communications and support programs to businesses.

The Board of NMBA would like to thank Northern Midlands Council for its support to date in allowing the Association to continue its usual activities while also providing valuable Covid-related communications and assistance to our business community.





Climate Change - Proper Acknowledgement and Emergency Action

Established in 1911, the Local Government Association of Tasmania (LGAT) is the representative body of Local Government in Tasmania, incorporated under the *Local Government Act 1993*. With membership comprising all 29 Tasmanian councils, the core purpose¹ of the Association is to:

- Protect and represent the interest and rights of Councils in Tasmania;
- Promote an efficient and effective system of Local Government in Tasmania; and
- Provide services to Members, Councillors and employees of Councils.

In turn, our members' functions² are to:

- Provide for the health, safety and welfare of the community;
- Represent and promote the interests of the community;
- Provide for the peace, order and good government of the municipal area.

LGAT executes its role to support Tasmanian councils' functions within our communities.

The Local Government Association of Tasmania (LGAT) holds four General Meetings every year to formulate and ratify the policy of LGAT and sector positions on important issues. I write to you seeking your support in addressing and advancing a motion passed at the

Local Government Association of Tasmania's (LGAT) July 2019 General Meeting. The motion reads as follows:

That the LGAT call upon the Federal and Tasmanian State Governments and Parliaments urging them to:

- a) Acknowledge the urgency created by climate change that requires immediate and collaborative action across all tiers of government;
- b) Acknowledge that the world climate crisis is an issue of social and environmental injustice and, to a great extent, the burden of the frontline impacts of climate change fall on low income communities, vulnerable groups and future generations; and
- c) Facilitate emergency action to address the climate crisis, reduce greenhouse gas emissions and meet or exceed targets in the Paris Agreement.

The motion originates from Huon Valley Council (ratified by a majority), a beautiful rural council at the gateway to Australia's Tasmanian Wilderness World Heritage Area where communities there bore the brunt of the January 2019 bushfires. A copy of the complete motion with background commentary is attached.

The motion was one of two separate and independent motions at the July 2019 General Meeting that both relate to the rapidly growing view within communities of a sense of emergency arising from climate-related impacts and the urgent need for meaningful action. The other motion originated from Devonport City Council, an urban council and in many ways very different to Huon Valley Council and not directly impacted by the bushfire events of January 2019, highlighting several important factors for your consideration:

- How very different communities are increasingly viewing the series of bushfire, flood and coastal hazards events experienced as a collective set of related events and a pattern of evidence;
- How these patterns and communities' experiences with hazard events are increasingly validating for them the climatic patterns predicted by a vast body of local and global scientific evidence; and
- 3. How even communities removed from direct impacts of climate-related events care deeply for the welfare of not just their own local communities, but of their neighbours and the welfare of all Australians. This empathy is explicit in part (b) of the motion.

Devonport City Council's motion was withdrawn only because it was felt it was dealt with sufficiently by Huon Valley Council's motion.

We note that the motion does not call for any official declaration of a climate emergency, despite it clearly recognising the "urgency", that there is a "climate crisis" and the need for "emergency action". Please understand the important meaning behind this, it is not an objection to any official declaration of a climate emergency but a deliberate intention to avoid what some see as a distracting political statement and to instead focus on meaningful action to support communities feeling the brunt of climate-related hazard events. Nevertheless, an official declaration of a climate emergency (or similar) by your government would be consistent with this motion and demonstrate your government's commitment in spirit to Tasmania's councils and local communities.

At the heart of this motion, supported by our membership, are three things:

- The need for acknowledgement of the issue in terms that are consistent with the science and the lived experiences of communities;
- 2. The desire to both understand those most vulnerable to the impacts of a changing climate and to stand together in attempts to address it;
- The urgent concern of Tasmanian communities to focus on meaningful collaborative action, particularly in terms of mitigation, addressing what is seen as the root cause of climate-related intensification of hazards, being greenhouse gases.

In addressing this motion, it is important to understand that many communities and individuals feel an acute and often constant sense of vulnerability to climate-related impacts and that these impacts have the potential to devastate their properties, livelihoods and even their lives. The unprecedented spread of bushfires across Australia in the last two months and the devastation they have caused communities only serves to reinforce this anxiety.

Prime Minister, we are aware of your government's commendable actions and initiatives in addressing climate change and while repeating them here is still useful, this motion clearly seeks more. It seeks a genuine response to acknowledge the scope of the problem and commitment to stand together with local communities to address it. This Local Government motion does not seek your action alone but identifies itself as active participants in creating collaborative action across all tiers of government.

Therefore, in addressing this Tasmanian Local Government motion, could you please provide your advice to the following:

- 1. How do you see the Australian Government role in working with Tasmanian councils and the Tasmanian State Government to facilitate meaningful mitigation action on climate change?
- 2. In what ways is your government advocating to the governments of other nations to properly acknowledge the way local communities are experiencing climate-

- related hazard intensification and to facilitate urgent and meaningful action to resolve our contribution to the problem?
- 3. How do you personally and your government intend to respond to the call of this motion for clear acknowledgement of a world climate crisis (or emergency), its extent and nature, the urgency of response, and the particular vulnerability of low income individuals and future generations to the impacts of insufficient action?

Independent from this motion, our national peak body, the Australian Local Government Association (ALGA), in its submissions to your government's budgets³ is calling for what is essentially the same thing, collaboration with your government to create meaningful local action that responds to our changing climate. These submissions seek:

- Investment in a Local Government Climate Change Partnership Fund of \$200 million over four years
- Funding for a targeted disaster mitigation program at a level of \$200 million per annum for four years

These national programs would support councils' work across the country in both mitigation and adaptation, assisting their communities with their local responses to climate change and defending communities from the impacts of natural disasters.

Tasmania and particularly the Huon Valley is increasingly vulnerable to the impacts of climate change, particularly sea level rise, bushfires, floods and drought.

There is a strong feeling that climate change is not being addressed by Governments in a collaborative and effective manner.

The Federal and State Governments have the potential for the greatest influence on climate change related matters and yet they do not provide adequate resources and direction to addressing climate change impacts and often pass down responsibility to Local Government and local communities to find their own solution.

Each instance cannot casually be corelated to altered climate but taken together they form a pattern in people's minds that match the climatic patterns predicted by a large body of global scientific investigation.

The number of positive initiatives undertaken by the Government is acknowledged (as detailed in the Tasmanian Government comment below) however, members should be aware that the 2019-20 State Budget Papers indicate an end to State Government funding for its Climate Action 21: Tasmania's Climate Change Action Plan 2017-2021 from the end of the 2021 financial year (only two years away) resulting in a significant reduction in forecast funding from that period onwards. This coincides with the end of the Action Plan however, funding has not been forecast or allocated for a replacement plan or what continuation past the point might look like.

Tasmanian Government Agency Comment

The Climate Change (State Action) Act 2008 (the Act) sets the Tasmanian Government's legislative framework for action on climate change.

Following the most recent independent review of the Act, completed by Jacobs Australia in 2016, the Department of Premier and Cabinet's Tasmanian Climate Change Office is currently leading a project to amend the Act.

Amendments to the Act are scheduled to be tabled in Parliament this year. The proposed amendments include setting a new greenhouse gas emissions target for Tasmania in line with international agreements.

It is important to note that Tasmania's total contribution to national carbon emissions is the lowest of any state or territory and, according to the *State and Territory Greenhouse Gas Inventories 2016*, represented a net negative contribution of -0.01 metric tonnes of carbon dioxide equivalent emissions (see Figure 1, below).

Climate Change - Proper Acknowledgement and Emergency Action

I write to you seeking your support in addressing and advancing a motion passed at the Local Government Association of Tasmania's (LGAT) July 2019 General Meeting. The motion reads as follows:

That the LGAT call upon the Federal and Tasmanian State Governments and Parliaments urging them to:

- a) Acknowledge the urgency created by climate change that requires immediate and collaborative action across all tiers of government;
- b) Acknowledge that the world climate crisis is an issue of social and environmental injustice and, to a great extent, the burden of the frontline impacts of climate change fall on low income communities, vulnerable groups and future generations; and
- Facilitate emergency action to address the climate crisis, reduce greenhouse gas emissions and meet or exceed targets in the Paris Agreement.

The motion originates from Huon Valley Council (ratified by a majority), whose communities bore the brunt of the January 2019 bushfires. A copy of the complete motion with background commentary is attached.

The motion was one of two separate and independent motions at the July 2019 General Meeting that both relate to the rapidly growing view within communities of a sense of emergency arising from climate-related impacts and the urgent need for meaningful action. The other motion originated from Devonport City Council, in many ways a very different council to Huon Valley Council and not directly impacted by the bushfire events of January 2019. This highlights several important factors for your consideration:

 Very different communities are increasingly viewing the series of bushfire, flood and coastal hazards events experienced as a collective set of related events and a pattern of evidence;

- Communities' experiences with hazard events are increasingly validating for them
 the climatic patterns predicted by a vast body of local and global scientific
 evidence; and
- 3. Even communities removed from direct impacts of climate-related events care deeply for the welfare of not just their own local communities, but of their neighbours and the welfare of all Australians. This empathy is explicit in part (b) of the motion.

Devonport City Council's motion was withdrawn only because it was felt it was dealt with sufficiently by Huon Valley Council's motion.

We note that the motion does not call for any official declaration of a climate emergency, despite it clearly recognising the "urgency", that there is a "climate crisis" and the need for "emergency action". Please understand the important meaning behind this, it is not an objection to any official declaration of a climate emergency but a deliberate intention to avoid what some see as a distracting political statement and, to instead focus on meaningful action to support communities feeling the brunt of climate-related hazard events. However, an official declaration of a climate emergency (or similar) by your government would be consistent with this motion and demonstrate your Government's commitment in spirit to Tasmania's councils and local communities.

At the heart of this motion, supported by our membership, are three things:

- The need for acknowledgement of the issue in terms that are consistent with the science and the lived experiences of communities;
- 2. The desire to both understand those most vulnerable to the impacts of a changing climate and to stand together in attempts to address it; and
- The urgent concern of Tasmanian communities to focus on meaningful collaborative action, particularly in terms of mitigation addressing what is seen as the root cause of climate-related intensification of hazards, being greenhouse gases.

In addressing this motion, it is important to understand that many communities and individuals feel an acute and often constant sense of vulnerability to climate-related impacts and that these impacts have the potential to devastate their properties, livelihoods and even their lives. The unprecedented spread of bushfires across Australia in the last two months and the devastation it has caused communities only serves to reinforce this anxiety.

Premier, we are well aware of your government's commendable actions and initiatives in addressing climate change, and while repeating them here is still useful, this motion clearly seeks more. It seeks a genuine response to acknowledge the scope of the problem and commitment to stand together with local communities to address it. This Local

Government motion does not seek your action alone but identifies councils as active participants in creating collaborative action across all tiers of government.

Therefore, in addressing this Tasmanian Local Government motion, could you please provide your advice to the following:

- 1. What role do you see for the Tasmanian Government in working with Tasmanian councils and the Australian Government to facilitate meaningful mitigation action on climate change?
- 2. In what ways is your Government advocating to the Australian Government to properly acknowledge the way local communities are experiencing climate-related hazard intensification and facilitate urgent and meaningful action to resolve our contribution to the problem?
- 3. How do you intend to respond to the call of this motion for clear acknowledgement of a world climate crisis (or emergency), its extent and nature, the urgency of response, and the particular vulnerability of low income individuals and future generations to the impacts of insufficient action?

Premier, it is clear that Local Government wants to collaborate with you in creating a legacy of responsible economic behaviour and land stewardship so that the communities we work in and create for the future are stable and resilient to climatic variation.
